**Exculpatory Clause and Release**

**Further, by participation in the EVENT, PARTICIPANT expressly agrees that CROWDER shall not be liable for any damages arising from personal injuries, property damage, other loss, expense, or claims, even in the event of CROWDER'S negligence or fault, which PARTICIPANT might sustain and which arise in any way from participation in the EVENT. PARTICIPANT has been advised, and is aware of the dangers of participating in the EVENT, and expressly agrees that even in the event of actual or alleged negligence on the part of CROWDER, PARTICIPANT assumes all risks of injury, loss, or damages to PARTICIPANT'S person or property, which may occur as a result of participation in the EVENT.**

**PARTICIPANT further affirms that PARTICIPANT has received, read, and executed an SCCA Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement (the SCCA RELEASE) for the EVENT. PARTICIPANT acknowledges that CROWDER is to be considered a RELEASEE under the terms of the SCCA RELEASE and that the terms and conditions of the SCCA RELEASE are incorporated by reference as if fully set forth herein.**
